Last month I started a discussion about CSI members without chapter affiliation. A study by Institute identified several reasons why some CSI members haven't joined a local chapter: meeting times didn't work, chapter was too far away, couldn't afford the dues, paying for an occasional meeting was a better value than the annual dues, chapter program wasn't worth the cost. Whatever your reason, is there something we can do to increase the value of your CSI membership? If you aren't familiar with the activities of a chapter near you, I encourage you to check them out. There are contacts for each chapter at the end of this newsletter as well as on the NCR website. Some chapters have their own websites, but not all. One idea that we are researching is web-based meetings. While this has some limitations regarding question and answer sessions, open discussion, and even networking, it

Director's Message - At Your Service Needs Analysis

Have you ever heard a salesperson say, "let me tell you what you need!"?

Even seasoned sales professionals occasionally slip into the 'instructor mode' and attempt to guide a potential client to a pre-determined outcome. Well sure, the representative has much greater knowledge of her or his products or services. But without asking "how may I be of service?", without probing for the motivations behind your responses, without really listening to you, how can they be confident your needs will be met by their list of possible solutions.

As an association, we tend to drive potential new Members to the areas where we most need them rather than sincerely seeking to address their stated needs. We are still attempting to populate standing committees that have existed without reassessment or modification for decades. And we wonder why we are thought 'stodgy'? In our careers, we identify the needs of our client, assemble a project team with skills appropriate to the task, plan, execute, commission, celebrate, and start again. We know how to do this!

Let's conduct an exercise. Please give some thought to the following statements by prospective CSI Members and consider how we as individuals, as a component of CSI, as the professional design and construction community, might better serve:

- "I've accomplished a great deal, but now at the end of my professional career, I'd like to 'give back' to my industry".
- "I thought I was set. But now I'm the highest priced employee at a firm that failed to land the big project".
- "I've been asked to create an intern development program for our small firm".
- "I love what I do, and I'm thinking of starting my own company".
- "I'm new in town and have been tasked with establishing a branch office here".
- "I'm a new hire as a product rep, and I'm a little fuzzy on how all this works".



- "I need to help my firm develop new business, but I'm not very outgoing".
- "I want to be a 'starchitect', but I'm stuck doing stair wells on Revit".
- "I'm a student at the community college. How do know this career is right for me"?

I have no doubt that a healthy CSI chapter can be of value to each of these people. However, if we alienate them by forcing them into predetermined slots and drive them away with mundane 'box lunch' programs, we and they will miss a wonderful opportunity to engage in lifelong learning and relationship building.

A chapter, or region, or Institute that is attentive and responsive to the self-defined needs of our Members and our Community will become a magnet for those seeking professional career development and fellowship. Programs that address the common needs of those in our fields of endeavor will attract the attention and participation of those with whom we can share our experience and expertise. Isn't that what you were looking for when you came to CSI? Let's make this Organization strong again, let's re-create an innovative and energetic CSI for our time and our lives

Free Study Resource

Taking the Construction Document Technologist (CDT) exam and looking for a FREE study resource? Check out <u>SpecGuy.com</u> and click on CDT One Day At A Time! to register for a series of free daily question emails. The questions are based upon the Project Delivery Practice Guide (PDPG), the core of the CDT exam. This is an excellent way to bolster study group work, individual study, flashcards, and any other study method. Registered for an advanced exam (CCS, CCCA, or CCPR)? These questions are a great reminder of basic concepts that are the foundation of the advanced exams. To receive a free daily question email, seven days a week for 60 days, visit <u>SpecGuy.com</u>.

Certification Registration

Registration is underway for the Spring 2017 certification exams. Did you notice a couple of time changes from previous years? They are: Increased exam window and three time periods of registration fees. The increased Spring 2017 exam window is March 27th to June 2nd. That's 9-1/2 weeks of testing opportunity or procrastination, depending upon your perspective. And if spring isn't a good time of year, there's always the Fall 2017 exam window of September 25th to December 10th; which is 11 weeks! The combined exam windows are over one third of the calendar year. Neither time of year nor length of exam window can be a road block to taking a certification exam!

About the three time periods of registration fees: early, standard, and final. The early registration fee is the least expensive option, but ended January 24th for the Spring 2017 exams. Now is the standard registration period until February 27th. Can't decide or register during the standard registration fee period? Then two additional weeks to register are available until March 14th; at the increased final registration fee. To participate in the next early registration, plan for Fall 2017 early registration from June 26th to July 10th. Registering for the certification exams in either Spring or Fall 2017, the overall registration period for each is a little over 2 months. Plenty of time to decide!
